## BOARDING CONTRACT

This is a contract between DOG ON FUN, hereinafter referred to as “KENNEL,” and the individual whose signature appears on the back page, herein after referred to as “OWNER

1. OWNER agrees to pay the rate for boarding in effect on the date pet is checked in to the KENNEL
2. OWNER further agrees that the pet shall not leave KENNEL until all charges are paid in full to the KENNEL.
3. By signing this contract, OWNER certifies to the accuracy of all the information provided about said pet.
4. OWNER further agrees to be solely responsible for all acts or behavior of said pet while it is in the care of the KENNEL.
5. KENNEL reserves the right to contract OWNER or his agent and terminate the stay of the animal on the premises if KENNEL finds the animal to be hostile or creating an unusual nuisance, disturbance, or danger. OWNER or his agent will be required to remove the animal from the premises within twenty-four (24) hours. Failure to remove said animal from the premises within this time period permits KENNEL to place the animal in a veterinary hospital. All costs shall be borne by the OWNER of the animal. Only the period of actual stay at the KENNEL shall be charged as per the rates agreed upon.
6. OWNER specifically represents to KENNEL that the pet at no time has been exposed to rabies, parvo, distemper and/or canine cough during the thirty-day period prior to boarding.
7. Animal abandonment is a violation of the law and anyone who knowingly abandons any animal shall be prosecuted and, if necessary, claims will be filed in court to collect all fees due.
8. OWNER shall be solely responsible for all damages that pet may cause to KENNEL, it's attendants or any other person on KENNEL'S premises, other animals, or itself due to health problems, behavioral problems, or any other type of improper conduct.
9. OWNER acknowledges that KENNEL cannot be held liable for any mishaps of extraordinary and/or unusual nature including but not limited to biting, self-inflicted injuries, or accidental death.
10. I understand that KENNEL will do its best to ensure the safe return of all items brought in at the time of boarding but will not be responsible if they are damaged, misplaced or lost.
11. KENNEL shall not be liable for any airborne viruses, skin conditions, stress, or any other veterinary problem that may be either aggravated or acquired by the pet during its stay. If the pet becomes ill or if the state of the animal's health otherwise requires professional attention, KENNEL, in its sole discretion, may engage the ser-vice of a veterinarian or administer medicine or give other requisite medical attention to the animal, and the expense thereof shall be paid by OWNER. OWNER further agrees to pay all costs and charges for special services including supplies and medications that are used, requested and/or necessary, and all veterinary costs for the pet during the time said pet is in the care of the KENNEL.
12. KENNEL shall not be liable for any failure to perform in obligations because of acts of God, government controls, judicial order, riots, fire, or other casualty, or other causes beyond reasonable control of KENNEL.

Any controversy or claim arising out of or relating to this contract, or breach thereof, or as the result of any claim or controversy involving the alleged negligence by any party to this contract, shall be settled by arbitration in accordance with the rules of the American Arbitration Association, and judgement upon the award rendered by an arbitrator may be entered in any court having jurisdiction thereof. The arbitrator shall award attorney's fees and any deletions or additions to this contract shall be initiated by both parties.
14. This contract contains the entire agreement of the parties. All terms and conditions of the contract shall be binding on the heirs, administrators, personal representatives and assigns of OWNER and KENNEL.
15. KENNEL and OWNER agree to bound to the terms of this contract for all subsequent requests for boarding services made by OWNER and/or its agent and provided by KENNEL. Thus, unless a more recent contract is signed by KENNEL and OWNER, this contract shall be binding on both parties and their agents for all future boarding services.
